# Support for Ukrainians arriving in Northern Ireland

In light of an expected increase in queries in this area and the swiftly developing policy environment, we present below a number of links to useful information sources covering the help available to those fleeing the war in Ukraine.

nidirect is the primary source of official information for residents of Northern Ireland, and <u>key information</u> is available there for Ukrainians entering Northern Ireland, as well as those looking to help. The UK government has also set up a page covering <u>its response</u>, which is a useful way to check for further changes.

#### **Immigration**

You <u>must</u> exercise caution before offering any advice on immigration matters. Immigration advice is closely regulated by the <u>Office of the Immigration</u> <u>Services Commissioner</u> (OISC), and only those with relevant accreditation can advise someone on an application for immigration status. If you are in any doubt about your accreditation, you should signpost the client to an appropriately qualified immigration adviser.

The OISC <u>defines</u> immigration advice as giving an opinion on a course of action, or laying out options, specific to an individual client, while providing an immigration service means taking action on the client's behalf with the immigration authorities. If you do either of these things, both the organisation and the individual adviser must be properly accredited. However, it is permitted to provide access to information about immigration matters without accreditation, so long as the information is general and does not give an opinion about how client(s) should proceed.
